




Unload your pistol before any assembly or disassembly of the 20/20N stabilizer kit.

PISTOL INSTALLATION

Step 1

- Choose between high (6) or low (7) profile.
- Lock slide to the rear.
- Install the two halves over the cocking serration with provided hardware.





Step 2

 Secure the two side rails (1) by tightening the locking screw with provided hardware.



Step 3

- Secure the stock (11) in the folded position (see "folding the stock").
- Open the screw with provided hex key (17).



Step 4

- Lift the left frame.
- Insert the pistol into the slotted rail position and place the beaver tail into the rear tail slot,



Step 5

- Secure the two frame halves (5) by tightening the locking screw (4).
- Tighten until the gap between the two halves on the lower picatinny rail (3)



FOLDING THE BUTTSTOCK

Step 1

 To fold the buttstock [11], push the locking push button [10], swing the buttstock till it clicks and locks against the hinge on the frame [5].



Step 2

 To unfold the buttstock, hold the lever with your thumb and index, lift slightly and pull until the push button (10) locks.



G7 HOLSTER INSTALLATION

Step 1

 Secure the paddle (15) and the holster (14) in the desired angle and tighten with provided hardware.



Step 2


 Secure the paddle (15) and the holster (14) in the desired angle and tighten with provided hardware.



G7 PISTOL ADAPTER INSTALLATION

Step 1

 Secure the two adapter halves (16) on your handgun's picatinny rail with provided hardware.



Step 2

 Insert your handgun into the holster (14) as shown in the picture.
